Registration now has two steps:

Schedule info:

Registration begins at 8:30 a.m., the first session at 8:55.

There will be six sessions, either 45 or 55 minutes long, with 5 minutes between.

There is no specific lunch session - participants will select a time to eat based on the sessions they wish to attend. Morning coffee and lunch for advisers and speakers will be served in an adviser hospitality room. Students may use the campus center food court or shops to purchase lunch, or bring their own.

The program has been scheduled to end by 2:15 p.m.

Special events of Fall Press Day:

Write-off Contest:

One member of each staff may participate in the write-off sponsored by the *Record* newspaper. Immediately following the first keynote participants will report to the contest room where they will write a news story based on the presentation.

Judging will be completed and winners announced by the end of the day. Prizes provided by the *Record* will be sent to the school principal at a later date so that a presentation may be made at school.
